President's Report: President Hastings

Mayor Hastings requested the following Proclamations to be read into the record:

a.) Proclamation # 2019-1015 to establish National Gun Violence Awareness Day.

Mayor Hastings briefed all on his past trips over the last month to Springfield to testify before various Committees on behalf of Orland Hills and suburban municipalities.

He discussed the results of Orland Hills area legislators in obtaining \$8.365 million in funds to establish a regional Recreation Center in Orland Hills. He asked Trustee Roti to assist in planning the facility by Chairing a Committee to prepare a plan for layout and construction.

He elaborated on the new legislation that will allow municipalities to establish a three cent tax on locally purchased gasoline. The local tax would be in addition to an increase in the Motor Fuel Tax of 19 cents per gallon that would be shared with Illinois towns.

He also discussed the possibility of a Racino in Crestwood or Tinley Park and the addition Casinos in the Chicago area.

He indicated that all of the new landmark legislation is a once in a lifetime opportunity.
