NOTICE

In accordance with Section 2 of the Raffles Act (230 ILCS 15/2) and Section 116.07 of the Orland Hills Village Code, licenses shall be issued only to bona fide religious, charitable, labor, business, fraternal, educational or veterans' organizations that operate without profit to their members and which have been in existence continuously for a period of five (5) years immediately before making application for a license and which have had during that entire five (5) year period a bona fide membership engaged in carrying out their objects, or to a non-profit, fund raising organization that is organized for the sole purpose of providing financial assistance to an identified individual or group of individuals suffering extreme financial hardship as the result of an illness, disability, accident or disaster.

If a license is valid for more than thirty (30) days, the report shall be made monthly.
